ACE Year 2 Programme – applications invited!

Applications are now being invited for Year 2 of the ACE Programme. ACE stands for Achieving Community Empowerment and is a programme delivered by CHEX's parent organisation, SCDC (Scottish Community Development Centre) and funded by the Big Lottery Fund in Scotland (BIG).

ACE is a programme of support for community groups and, within it, SCDC provide at least 10 days of support for each group over the course of a year. The support will focus on the following areas:

- Helping groups to identify what they're good at it and where they need to improve/become more effective
- Helping groups to develop a plan of action in order to make their required changes
- Supporting groups to put their plan into action
- Sitting down with groups at the end of the year to review progress and identify what needs to be done next

Any community group can apply for support but SCDC will be prioritising those groups who need it most – particularly those groups who are in a period of transition or who feel that they are facing new challenges at the present time. Examples of groups participating in the programme so far are:

- Refugee Community Organisations including Y-People Glasgow Residents Association (YGRA), Karibu, AFIG (Ivorian Womens Group) and the Scottish Refugee Policy Forum
- Benarty Community Forum Group in Fife
- Groups working on issues around addiction including Grampian Family Support Forum, East Community Addictions Forum and ASURE
- Minginish Community Trust Association in Skye
- WISH (Women in Sport & Health) in Clackmannanshire

If you're having trouble in filling out the form, SCDC can advise you or you may want to ask a local support worker (if there is one) to give you a hand.

Applications need to be with SCDC by **31 August 2011**. SCDC will be short-listing at least 10 groups who they will then meet with to discuss their participation and fit with the programme before finally awarding support which will commence in October 2011.

Vote for Getting Better Together on 'People's Millions'!

CHEX network member Getting Better Together Shotts Healthy Living Centre (GBT) is a finalist in The Jubilee People's Millions 2011. GBT's Green Fingers Gardening will be put to the public vote on Wednesday 29th June where a short video about the project will be aired on STV's (Central) evening news between 6.00pm and 6.30pm.

The Big Lottery and ITV with the approval of Buckingham Palace will mark the Queen's Diamond Jubilee in 2012 through providing 60 awards of up to £60,000 to projects that seek to inspire and improve their local communities.

Green Fingers Gardening will go head to head with Campsie Memorial Hall Trust to gain public support and bid for funding of £50,853. This funding will enable GBT to transform an area of derelict ground into a sensory and market garden for the people of Shotts. The sensory garden will provide a restful space and will be accessible to wheelchair users. A series of raised beds and planting projects will enable the community of Shotts to become involved in growing their own produce and experiencing the freedom and pleasures of the outdoors. The youngsters of Shotts will be involved in creating a graffiti mural for the garden wall which will depict the theme of Shotts through the decades and will include reference to the Queen's Diamond Jubilee.

Voting for Green Fingers Gardening takes place on Wednesday 29th June between 9.00am – midnight. The phone number required for voting will not be released until the morning of the 29th June and will be advertised on www.peoplesmillions.org.uk and in the Daily Mirror. GBT appeals for the support of local people in voting for Green Fingers Gardening and greatly appreciates every vote cast.

Praise for low carbon communities

The Scottish Government's trail blazing Climate Challenge Fund (CCF) has been branded a success in a new independent review. The CCF scheme has invested £37.7 million in 345 community projects since 2008, helping reduce carbon emissions and building more sustainable communities.

Successful behaviour changing community projects include:

- Helping people to install home insulation, including applications for grant or subsidy
- Helping households increase their understanding of how to save energy and money by distributing energy monitors
- Promoting domestic renewable energy as a natural progression from basic home efficiencies to make this less daunting and increase uptake
- Developing food growing schemes which provided people with no prior interest with useful skills and space to grow their own food. Schemes also inform people where they can buy local sustainable produce, helping to broadened the appeal of eating in season
- Encouraging cycling and helping people back onto their bikes

Community Food and Health Scotland – ‘Meals & Message’ – findings from research on food services for older people living in the community in Scotland

CHEX attended the launch of CFHS's report into food services for older people living in the community in Scotland at Norton Park Conference Centre, Leith Edinburgh on Tuesday 21st June. Access to affordable, nutritious food is key to the health and wellbeing of older people in Scotland. The research investigated the nature and extent of food services provided to older people, older people's views of services, and the added value i.e. social interaction brought about by lunch clubs and other community based provision. The Bakers Awards

New Lottery Fund for Scotland's Community Spaces

We all know of those spaces in the heart of our local communities that with some care and attention could improve our local environment and make all our lives a little better. For some communities repairing the leaky roof of your local village hall could help find a new home for a pensioners' lunch club. For others this could be a piece of unused land which could be transformed into a community allotment, or a derelict play park which could be brought back to give local children a safe place to play.

Whatever the place the Big Lottery Fund's latest targeted funding programme - Community Spaces Scotland - will bring local people together to be healthier and happier by improving both indoor and outdoor community spaces. Community Spaces Scotland will target a total of £9 million of investment to support around 90 community led improvements to both indoor and outdoor spaces over three years. The programme will be targeted at areas where BIG believes it can make the biggest difference. In deciding on these targeted areas we have included a fair mix of large urban areas, small towns and remote rural areas. Groups can enter the postcode of their project base into the eligibility checker at www.biglotteryfund.org.uk/communityspaces which will tell them if they are in an eligible area straightaway.

The Big Lottery Fund want to fund community projects run for and by voluntary and community organisations to help local people take the lead in improving the space and places that matter to them. Schools, community councils and social enterprises can also apply. The Big Lottery Fund expect the average grant size to be around £100,000, but will accept applications for grants between £10,000 and £250,000. The Big Lottery Fund can award up to two years funding.

### Networking Event at Gardening Leave

*Thursday 25 August 2011, 12.30pm to 4.30pm  
Gardening Leave, Erskine, PA7 5PU*

Gardening Leave is a charity which aims to improve the mental and physical wellbeing of serving and ex-Service personnel using Horticultural Therapy, in walled gardens. All referrals are assessed by a member of the Veterans' Assessment Team who are Community Psychiatric Nurses with military experience either in the Regulars or the TA. Assessments cover risk and management of expectation and are not diagnostic. Referrals to Gardening Leave are made via other Service charities and healthcare professionals and self-referrals are welcome. Evidence of proof of service will be requested.

All Gardening Leave projects are run by a Horticultural Therapist, supported by carefully selected volunteers and are open Monday to Friday. The Horticultural Therapist writes a daily Evaluation of each veteran who has attended Gardening Leave based on the Reasons for Referral given by the Assessor which is sent to the referral agency regularly.

No charge is made for attending Gardening Leave, lunch and refreshments are provided and there is no finite number of sessions allowed; many veterans miss the sense of belonging to something when they leave H.M. Armed Forces and return to civilian life and being part of Gardening Leave can mitigate this is a small way. The Charity is funded entirely by grant-making trusts and public donations.

The Networking Day at Gardening Leave Erskine will be an opportunity to meet Gardening Leave staff and the Mental Health Foundation researchers who are conducting a 2 year External Evaluation of the project and its sister project Gardening Leave Chelsea based at the Royal Hospital Chelsea in London. All interested healthcare professionals and potential referral agencies are very welcome to attend this free event.

## **The Big Society in Scotland: Public services, mutual models and the third sector**

This conference will examine the Westminster Government's Big Society objectives of promoting social action and empowering communities and will ask whether this can work in Scotland.

The Prime Minister wants The Big Society to give citizens, communities and local government the power and information they need to come together, solve the problems they face and build the country they want. Supporting the transfer of central and local government decisions and responsibilities to local communities, a Big Society Bank will provide finance for neighbourhood groups, charities, social enterprises and other non-governmental bodies.

Critics say it is a smokescreen to lessen the impact of the public spending austerity drive, but given the effect this will have in Scotland, does the Big Society offer a genuine opportunity for doing the same – or more – at lower cost while empowering local communities?

Is there a new role for the third sector and private sector in Scotland? Should the Scottish and UK Governments work to develop appropriate models for a Big Society strategy for Scotland, enabling Scottish communities to benefit from the Big Society Bank? Does Scotland already have the right balance between public provision, private innovation and third sector support to make the Prime Minister's crusade unnecessary here?

a) Quality in Social Research - 2 day course – 6 places left
